### **OPERATIONAL ACTION PLAN 2024-2027**

As part of the implementation in its 2024-2027 operational action plan, ACAI has developed a fundraising plan composed of letters of intent and project proposals in the following sectors and themes: Forests, low-carbon agriculture, waste, renewable energies and forest residues, water, law, governance and advocacy.

# Our short-term priority Actions and Projects:

**1. Implementation of the ACAI Fundraising Plan:** Contacts have been made with more than 150 leaders of foundations, international organizations, philanthropists and other donors, as well as project letters of intent sent.

The ACAI is organizing to put in place coordination frameworks with its partners for the formulation of complete projects and budgets.

2. Institutional, organizational, operational and financial support project for the ACAI executive office and regional technical commissions. The headquarters is in Accra, Ghana, headed by **Mr Eric Lartey.** 

Since February 2024, the Women's Mobilization and Mentoring Directorate has been operational and led by **Dr Laurelta AHEROBO**, who together form an essential driving force in the fight against climate change, bringing their expertise, their passion and





their determination to build a future more and resilient and sustainable for generations to come.

**3**. Women's Coalition workshop project in March: the objective is to advance women's participation in natural resource governance and climate action in Africa

**4. Global project for Ghana, Senegal and Nigeria (see ACF-ACAI minutes**): This project aims to promote sustainable development through the integration of social and environmental initiatives, with a specific emphasis on sustainable land use and agriculture. The objective of this proposal is to define a strategic framework that leverages political and financial mechanisms to bring about positive change in the 3 African countries.

**5. TAPP-ACAI Coalition Advocacy Workshop Project:** This project for a regional awareness, communication and information workshop on the Climate Loss and Damage Fund, a crucial initiative adopted at COP28 in Dubai and advocacy targeting wealthy OECD countries and China, urging them to implement policies to reduce meat consumption as part of their fight against climate change and mitigation strategies.

6. Women's Empowerment in the Age of Climate Transformation (WEACT) Project: This is an initiative of ACAI and its Canadian partners. This project will be adapted and implemented in collaboration with partners in Burkina Faso (Association d'Appui à la Promotion du Développement Durable des Communautés (APDC), Ghana (Rights and Advocacy Initiatives Network (RAIN) and Uganda (CAPAIDS Uganda (C-UG).

With women from targeted regions, using local women's associations as an entry point, to increase women's economic empowerment through adoption of NbS for climate adaptation, meaningful participation in design and scaling up NbS for climate adaptation within communities, and amplifying women's voices, experience and leadership in climate resilience policy and decision-making, thereby strengthening empowerment and women's leadership in strengthening community climate resilience.

**7. IFED Canada/ACAI Project:** The main objective of this project is to organize online meetings to launch and strategize a think tank project aimed at identifying potential partners who can provide financial support to in-depth investigations focused on understanding the impact of climate change on agriculture in African countries.
